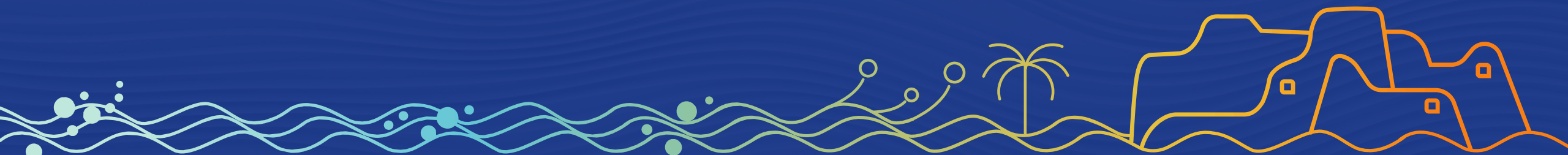

World Water Forum Processes



Political

During a closed discussion, **political representatives** emphasized the importance of advancing the **political process** for global water management and shared key priorities:

- **Strengthening** coordination across all political levels
- **Ensuring** the inclusion of end users in decision-making
- **Bridging** key procedures and results with the key water events in 2026 and 2027
- **Stressing** collaboration, investment, resilience, and the elevation of water as a political and societal priority



Thematic

The thematic **process underpins the Forum's content.**

During two days, all participants actively participated in the **breakout sessions** on the following **six themes**, where they held their initial exchange of ideas and devised the key potential **topics for each theme** of the 11th World Water Forum:

- Water Security, Water Finance, Water Diplomacy, Water for Humans and Nature, Value of Water, Innovation for Water

Regional

During a plenary discussion, all regions called out for deeper **collaboration** and shared their **priorities to**:

- **Specify** regional priorities and local action plans to share and implement solutions under Forum themes
- **Facilitate** regional dialogues & cooperation by identifying water challenges and solutions
- **Catalyze** exchange of ideas, and potential solutions across regions on common water issues
- **Strengthen** regional stakeholders to raise water's political profile in the respective region

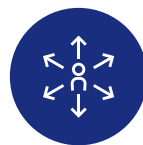

Strategic Synergy

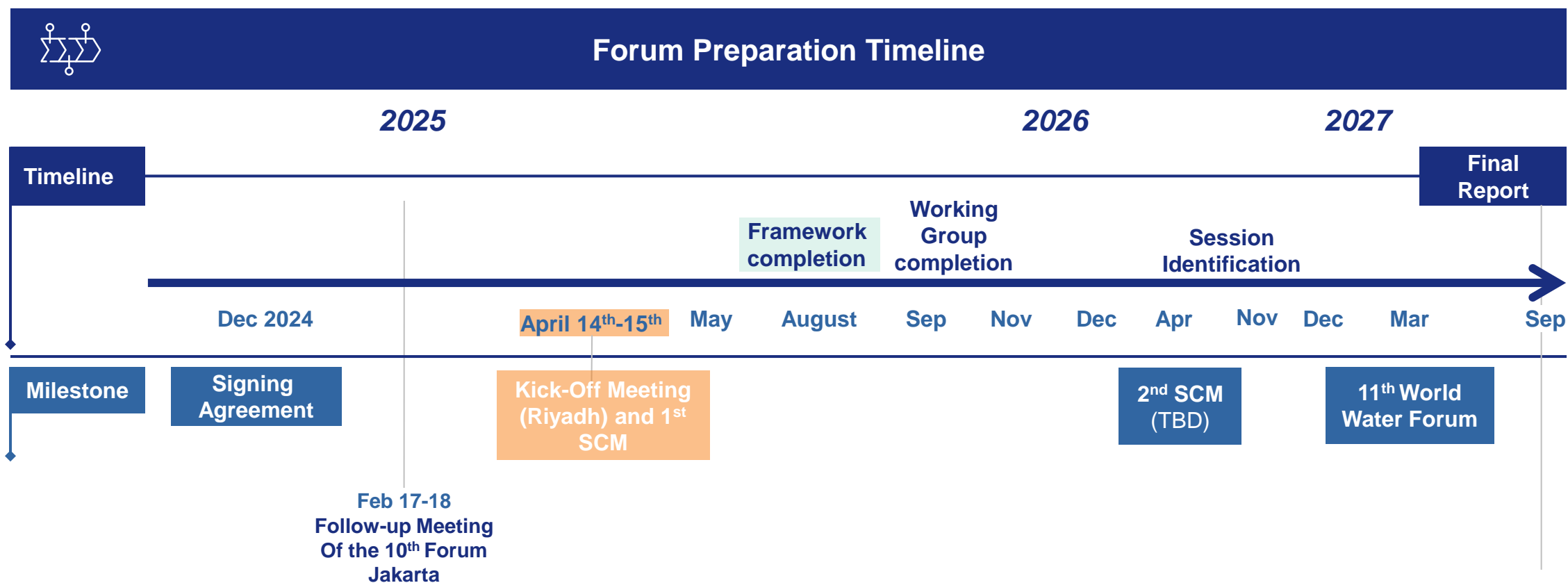
- By aligning with major global water events like the 2026 and 2028 UN Water Conferences, the Forum will broaden perspectives and amplify key messages and outcomes across all tracks
