



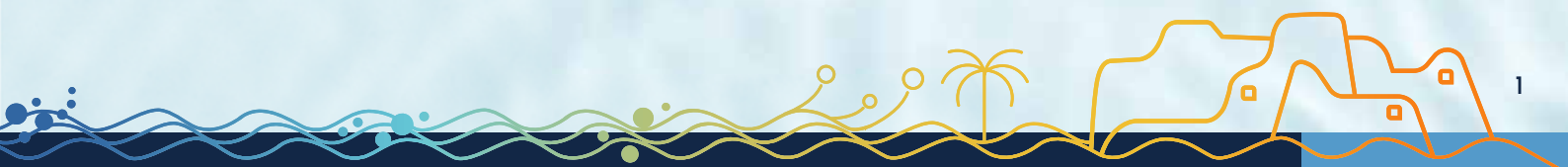

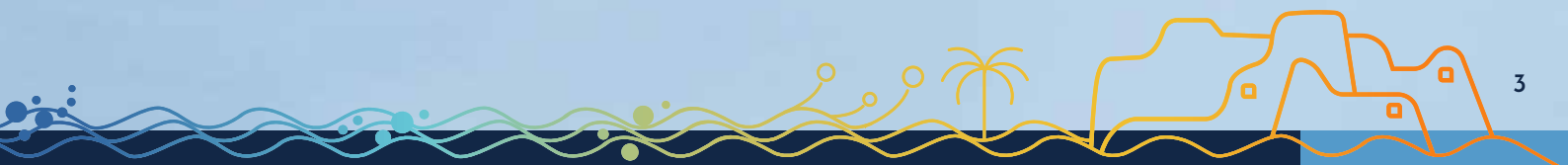

01 WELCOME ADDRESSES





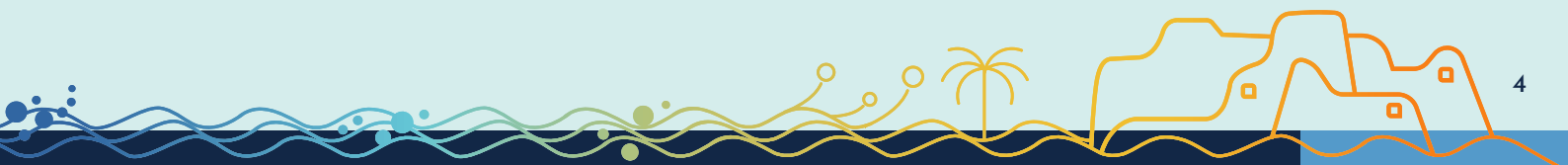

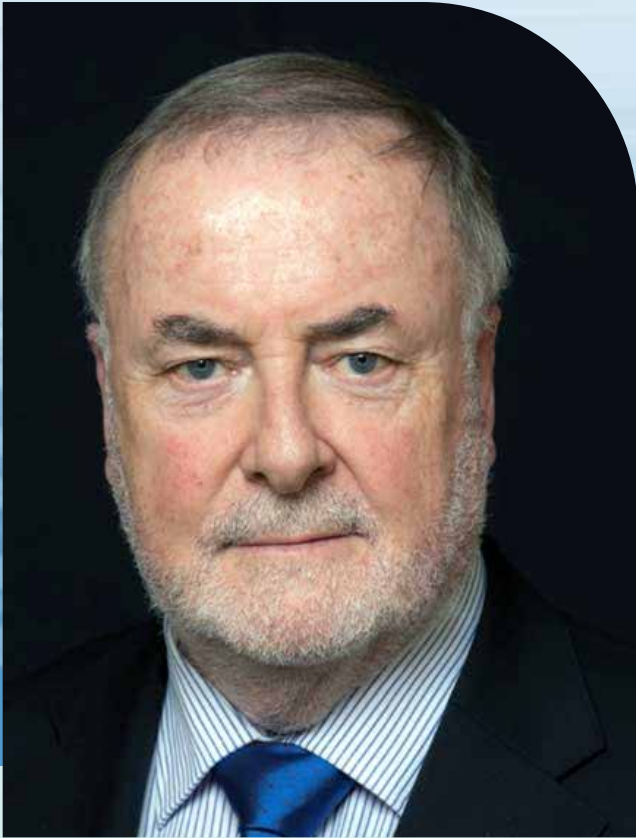

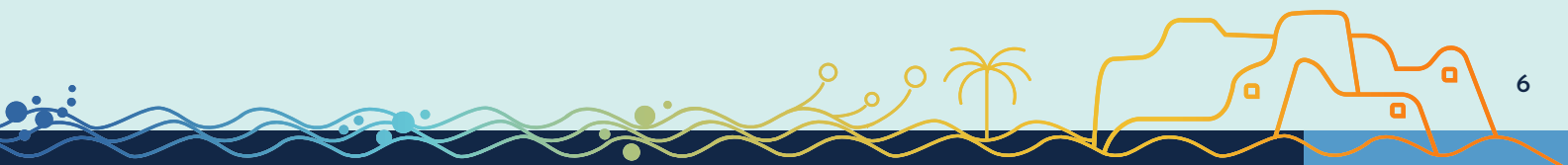

02 INTRODUCTION

2.1 THE WORLD WATER FORUM AND ITS HISTORY

Since its inception in 1997, the World Water Forum has evolved into the largest international platform devoted to addressing the world's most pressing water challenges. Held every three years, this event brings together policymakers, experts, academia, civil society organizations, private sector leaders, entrepreneurs, economists, innovators, community leaders, investors, civil society actors, and youth to drive collaboration and community-driven action, unlike other forums that limited stakeholders to only governments and policy makers.

Serving as a catalyst for international water policy, the Forum tackles today's critical challenges head-on—from chronic water scarcity and destructive floods to safeguarding water quality, strengthening transboundary cooperation, and mobilizing innovative financing. Through high-level political engagement, multi-stakeholder dialogues, and dynamic knowledge-sharing initiatives, it has become a cornerstone of global efforts to sustain water resources and build resilience.

At the heart of the World Water Forum stands the **World Water Council (WWC)** - an independent, non-governmental organization (NGO) officially established in 1996 and headquartered in Marseille, France.

Comprising over 260 member organizations from 52 countries across five continents, the WWC was established with a singular **goal**: to promote sustainable water management at all levels and ensure water remains a central priority on the global development agenda. Since its founding in 1996, the World Water Council has played a crucial role in shaping the global water agenda, promoting global collaboration and knowledge sharing on water

challenges, mobilizing political will, advancing sustainable water management strategies, leading innovation in water conservation, empowering water financing and bolstering water governance through the World Water Forum.

Over last three decades, each edition of the Forum—hosted in diverse countries around the world—has infused unique **regional perspectives** while **addressing universal water challenges**. With structured engagement through **thematic, regional, and political processes**, the Forum has consistently delivered impactful outcomes, including ministerial declarations, stakeholder commitments, and breakthrough strategies on key issues such as water financing, and cutting-edge innovations, closely aligned with the **United Nations Sustainable Development Goals (SDGs)**, particularly **SDG 6**, which aims for universal access to clean water and sanitation. These outcomes have influenced policy reforms and accelerated the adoption of sustainable water management practices worldwide. The Forum's overarching themes have evolved from "Vision for Water,

Life and the Environment" (Marrakesh 1997) to pivotal slogans such as "Bridging Divides for Water" (Istanbul 2009), "Time for Solutions" (Marseille, 2012), and "Water for Shared Prosperity" (Bali 2024), mirroring the shift from awareness-raising to action-oriented, inclusive water governance.

Beyond policy, the Forum celebrates and rewards excellence in leadership and innovation in water. In 2003, it was the birthplace of the prestigious **King Hassan II Great World Water Prize**, honoring individuals, institutions, and organizations that have made groundbreaking contributions in water management and cooperation at a global scale. In 2006, it launched the **Kyoto World Water Grand Prize**, recognizing grassroots initiatives that pioneer innovative water solutions. These awards mobilize high-level international partnerships and reinforce the Forum's commitment to leadership, innovation, and inclusive solutions, scaling best practices across the world.

In March 2027, the WWC and Riyadh will host the 11th World Water Forum, marking its 30th anniversary with the most ambitious edition yet—welcoming **over 20,000 contributors and 150,000 visitors** from **more than 150 countries** under the overarching theme "**Action for a Better Tomorrow**", the Forum will address water and development for broader global challenges of innovation, financing, cooperation, and inclusive development with greater emphasis on ground level action. As one of the most water-scarce nations, the Kingdom has pioneered advanced desalination technologies, smart governance models, and sustainable financing frameworks, proving that transformational progress is possible even under extreme conditions. The 11th World Water Forum will be a platform to scale these lessons, amplify diverse voices, and usher in a new era of global cooperation—one that bridges geographies, sectors, and generations to drive sustainable actionable solutions for the future.

Saudi Arabia’s experience in the water sector will provide valuable insights—not only for nations facing similar challenges but also for the world, as **climate change intensifies water-related risks**. This Forum is dedicated to fostering **transformative discussions that move beyond theory to an action-oriented agenda**, prioritizing **policy implementation, cross-sector collaboration, regional problem-solving, and sustainable development**—ensuring a Forum of memorable outcomes that delivers **regional breakthroughs with global learning**. As co-host and the world’s longstanding platform for water dialogue, the World Water Council will leverage the human and intellectual capital accumulated across the first ten editions of the World Water Forum, together with the expertise and experience of host nation Saudi Arabia, to guide every track of the 11th Forum toward the best possible outcomes.

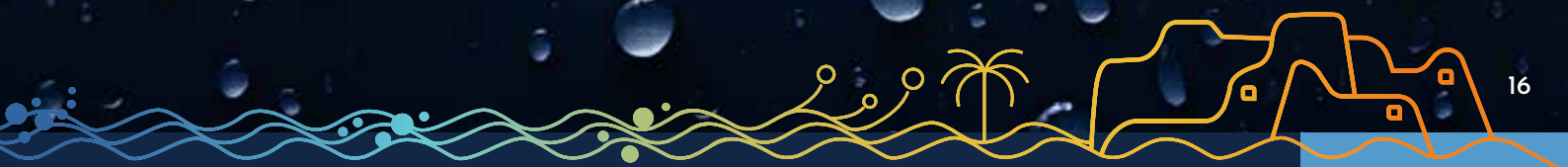



Overarching Theme

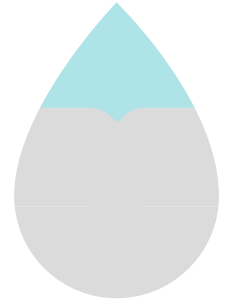

POLITICAL PROCESS



The **Political Process** of the World Water Forum serves as a platform for engagement among governments, parliamentarians, ministers, local authorities, and basin authorities to shape policies and drive political action on water-related challenges. It ensures that decision-makers prioritize sustainable water governance and commit to concrete solutions.

Importance

Water governance is inherently political, requiring strong leadership, cross-border cooperation, and policy alignment. The Political Process highlights the critical role of political decision-making in securing water resources, taking into account both human and environmental needs. It aims to **strengthen global collaboration, integrate water into political agendas, and foster partnerships** that lead to long-term, effective water solutions.

11th Forum's Contribution

The **Political Process of the 11th World Water Forum** is designed to engage leaders at all levels, ensuring that water-related challenges are met with **strong political will, cross-border cooperation, and policy-driven action**.

Heads of State

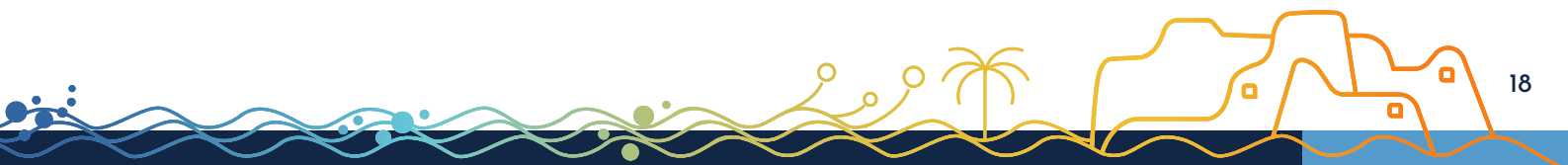
Ministers

Basin Authorities

It promotes innovative approaches to managing shared water resources, ensuring equitable distribution, and mitigating conflicts through cooperative frameworks.

By uniting bold political leadership with actionable commitments, the 11th World Water Forum will be a landmark moment—**strengthening governance, advancing policy innovation, and mobilizing decision-makers** to turn ambition into lasting impact. **11th Forum** will set a new standard for translating **political will into real-world water solutions**.

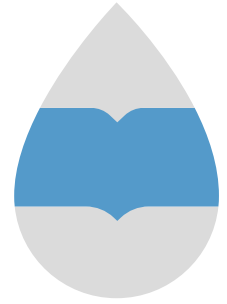

THEMATIC PROCESS



The **Thematic Process** of the **11th World Water Forum** is designed to drive knowledge-sharing, collaboration, and innovation in water governance. By focusing on **key global and regional challenges**, this process enables stakeholders to develop targeted, actionable solutions that address both local and international water issues.

Importance

The Thematic Process is essential in **shaping policies and strategies** that address the most pressing water-related challenges worldwide. It facilitates the **exchange of best practices**, fosters cooperation among stakeholders, and influences policy decisions. It creates a **structured approach** where **knowledge is translated into real-world solutions**, ensuring sustainable water management.

11th Forum's Contribution

The **11th World Water Forum** strengthens the **Thematic Process** by addressing **six key areas** critical to global water security, ensuring that discussions translate into **practical solutions, policy innovation, and strategic investments**. Some topics, such as resilience and water quality, may naturally intersect between Themes but will be treated through their primary focus lenses.

The 11th Forum aims to foster collaborative solutions and actionable strategies across six key water priorities. The discussions and initiatives will focus on:



Water Security

Strengthening climate resilience, enhancing equitable access through rights-based approaches, and improving water quality via ecosystem protection and integrated water resource management (IWRM), all while supporting food and energy security within a circular economy framework

Water Finance

Advancing innovative financing models such as blended finance, fintech, and adaptive tariffs; catalyzing private sector engagement and smart subsidies; and ensuring sustainable water and sanitation services through risk-informed

investment strategies and lifecycle costing—especially for vulnerable and remote communities

Water Diplomacy

Fostering transboundary and cross-sectoral cooperation, supporting legal frameworks for shared governance, and promoting inclusivity and human rights through science-to-policy dialogue, advocacy, and robust data sharing mechanisms

Water for Humans & Nature

Promoting resilient, inclusive, and community-based approaches through One Health alliances, Nature Based Solutions, protection of Biodiversity and enabling smart, tailored solutions grounded in knowledge exchange and robust stakeholder governance

Value of Water

Embedding water's multifaceted value—social, cultural, economic, and ecological—into national and subnational policies. This includes contextualized pricing, multi-stakeholder collaboration, circular

economy principles, water footprint assessment, and capacity building through public awareness and education

Innovation for Water

Accelerating the uptake of smart digital technologies and AI-driven solutions, fostering knowledge sharing and capacity building, promoting smart community practices, and aligning regulatory frameworks to scale nature-based and advanced technological innovations

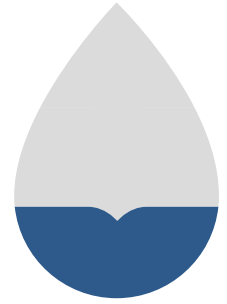

Strengthening regional dialogues ensures that global commitments translate into context-specific customized actions, fostering sustainable water management practices that reflect local priorities and promotes global learning from grassroot level innovation.

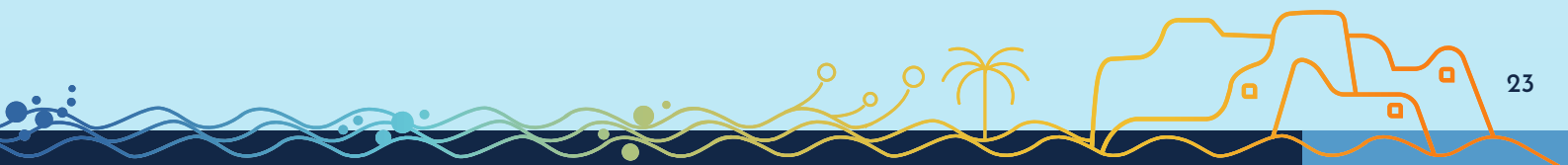


11th Forum's Contribution

HIGHLIGHTS FROM 1ST STAKEHOLDERS' CONSULTATION MEETING

Riyadh successfully hosted the 1st Stakeholder Meeting of the 11th World Water Forum on 14th and 15th April 2025, uniting over 600 participants from 60 countries and organizations—including ministers, experts, researchers, and senior professionals—in a pivotal alignment around shared global water challenges.

Marking the first official milestone of the Forum's overarching theme, "Action for a Better Tomorrow," the meeting served as a strategic platform to forge consensus around global water priorities. Discussions focused on advancing solutions that strengthen water security, mobilize sustainable financing, foster diplomatic cooperation, and drive innovation—while ensuring equity, safeguarding ecosystems, and recognizing water's fundamental value to people and the planet.

Engaging discussions across regional and political processes, alongside six parallel thematic breakout sessions, helped shape a shared vision and actionable agenda, laying the groundwork for joint solutions that reflect both urgency and unity in addressing the world's most pressing water issues.

Building on this momentum, the 2nd stakeholder meeting is scheduled for April 2026, as the journey continues towards the 11th Forum in Riyadh in 2027.



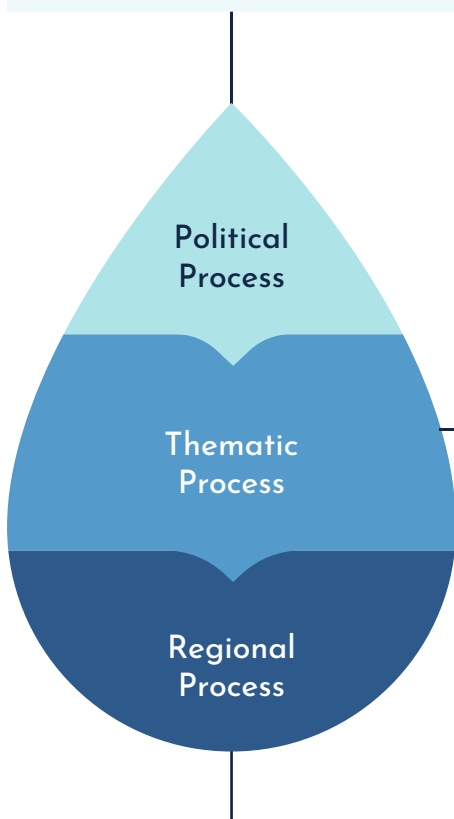

INSIGHTS FROM THE THEMATIC BREAKOUT SESSIONS



As part of the 1st Stakeholder Meeting for the 11th World Water Forum, **six parallel thematic breakout sessions** were convened by the World Water Council, the KSA Secretariat, and a broad network of local and international partners. These sessions focused on shaping the Forum's core thematic priorities: **Water Security, Water Finance, Water Diplomacy, Water for Humans and Nature, the Value of Water, and Innovation for Water.**

Each session was moderated by leading water specialists from Saudi Arabia and the international community, fostering inclusive participation and open dialogue. Stakeholders collaborated in a dynamic environment to exchange knowledge, share regional perspectives, and surface forward-looking ideas.

The discussions led to the identification of **key thematic keywords** and emerging priorities—ranging from climate resilience and equitable access to innovative financing, transboundary cooperation, community-led solutions, and the role of digital technologies. Tentative topics were also proposed under each thematic area to guide content development moving forward.

These insights lay a strong foundation for the development of targeted solutions for collective action at the 11th World Water Forum.

6.2 WATER PRIZES & AWARDS

The World Water Forum is a premier platform where innovation, leadership, and excellence in water management are recognized and rewarded through prestigious international Water Prizes. The 11th Forum looks forward to continuing this legacy, celebrating transformative contributions that advance global water governance and sustainability.

King Hassan II Great World Water Prize

Established in **2002** by the **Kingdom of Morocco** and the **World Water Council**, the **King Hassan II Great World Water Prize** honors the legacy of **King Hassan II** and his visionary approach to **water security and sustainable management**. Awarded every three years at the **World Water Forum**, it recognizes individuals and organizations excelling in **conservation, wastewater reuse, and public awareness**. First presented in 2003, the prize includes a **US\$500,000 grant**, a trophy, and global recognition.

Over the years, the prize has become a **catalyst for international water cooperation**, recognizing institutions like the **Organization for Economic Co-operation and Development (OECD)** and the **Senegal River Basin Organization (OMVS)**. In **2022**, OMVS was awarded for its transboundary water management, and in **2024**, the **Food and Agriculture Organization (FAO)** was honored for integrating **water security into global food systems**. By highlighting innovative efforts, the prize drives awareness and action in **sustainable water management worldwide**.

Kyoto World Water Grand Prize

Launched in **2003** by the **City of Kyoto** and the **World Water Council**, the **Kyoto World Water Grand Prize** recognizes **grassroots organizations** tackling **water and sanitation challenges** in developing countries. Awarded every three years at the **World Water Forum**, it highlights **community-led initiatives** in clean water access, sanitation, irrigation, and conservation.

The prize has spotlighted impactful projects across **Asia and Africa**, supporting **local solutions with global relevance**. Past winners include initiatives from **India, Uganda, Nepal, and Togo**. In **2024**, the award went to **Youth Sanitation Concern in Indonesia** for advancing water and sanitation access. By showcasing these efforts, the prize promotes **knowledge-sharing and strengthens community resilience** in addressing **water security challenges**.

Bali Youth Prize

Launched in 2024 by the Republic of Indonesia in partnership with the World Water Council (WWC), the Bali Youth Prize is the first youth-focused award introduced at the World Water Forum. It honors young individuals and initiatives driving innovation and leadership in water sustainability. Rooted in the principles of inclusive governance and community engagement, the prize reflects the WWC's commitment to empowering youth as vital actors in solving global water challenges.

Presented during the 10th World Water Forum in Bali, the inaugural prize highlighted impactful youth efforts in conservation, sanitation, climate resilience, and policy advocacy, including the Bali Youth Plan's call for greater youth participation in water governance. By elevating youth-driven solutions, the prize reinforces the essential role of young people in advancing sustainable water management worldwide.

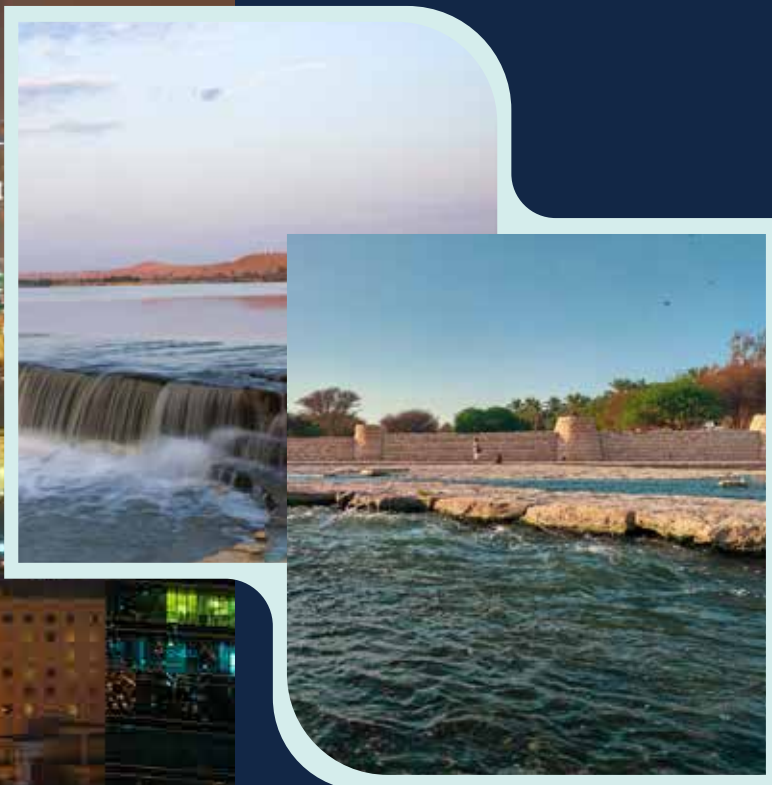
